RE: LACK OF RESPONSE FROM YOUR OFFICE

Dear Ms. Leong,

I again write to you with respect to the actions of your Staff and the formal complaint I brought to your attention in previous letters.

It is now into September 2016 and my many letters to you back in April and May have unfortunately received NO replies. From what I can tell, there is absolutely no reason why you, in your role of the Chair of the *British Columbia Securities Commission*, would not be able to respond. As you are very aware, I allege severe wrong-doing by two of your employees/former employees (**C. Paige Leggat** and **Olubode Fagbamiye**) in their *Submissions on Liability* in my case.

I will be candid and cut right to the point – I am looking for a reply to my allegation that your Staff manipulated evidence. Why do you continue to ignore these letters and fail to do your job? It would be appreciated if you would indicate to me whether there was/was not professional misconduct by your Staff. At any rate, you would think you would want to take steps accordingly to rectify the situation. For whatever reason, you choose to do neither which only makes you (and your entire organization) look foolish...and guilty. People in your position (and paid the salary your currently making) should not be able to ignore complaints lodged against your Staff.

In addition to my letter regarding the manipulation of evidence, I also brought forward in another letter a request for you to ascertain why your Staff (again C.
